II

GENERAL PROVISIONS

1. Prices include door-to-door delivery of express package deliveries and door-to-door delivery of euro pallet and cargo deliveries in the Republic of Croatia.
2. The dimensions, weight, volume and other conditions under which the service provider receives and delivers certain types of shipments are described in detail in Article 3 of the General Terms and Conditions for Other Postal Services "INTEREUROPA EXPRESS".
3. The premium for cargo insurance of individual package of marked value up to the amount described in detail in Article 6 of the General Terms and Conditions for the performance of other postal services "INTEREUROPA EXPRESS" is included in the price of other postal services, while for unmarked packages the price of other postal services includes transport insurance liability up to the amount determined by the General Terms and Conditions for the performance of other postal services "INTEREUROPA EXPRESS".
4. If the service user wants to insure the shipment beyond the amount specified in Article 6 of the General Terms and Conditions for the performance of other postal services "INTEREUROPA EXPRESS", a request for additional cargo insurance for an individual express or cargo package should be submitted. The service provider will charge the service user a premium to the amount of 0.25% of the marked value for the additional cargo insurance service.
5. For collection or delivery of packages to the islands, the prices are increased by 50% on the service price shown for Zone 2.
6. For collection or delivery of packages in the area of postal code 20, the prices are increased by 50% on the price of the service shown for Zone 2.
7. In case of returning the packages to the sender for any reason, the customer pays the return according to the price for delivery.
8. The service is calculated according to the total actual or calculated weight of the package from one sender to one recipient.
9. The fuel surcharge is calculated in the percentage published on the Service Provider's website www.intereuropa.hr on the last working day of the month for the following month.
